

EFT Quarterly Payment Schedule & Worksheet - JEDD Income Tax

NOTE: THE TAX RATE FOR ALL JEDDS IS 2.50%

Monthly filers must use the payment schedule and worksheet on the reverse side.

Employers may be required to remit monthly if their withholdings meet the threshold requirements described for monthly filers. Details to these state-mandated changes are available at the City of Akron website www.akronohio.gov/1040 and <http://codes.ohio.gov/orc/718>.

Filing and payment can be done using one of three approved electronic filing methods. The worksheet below should be used to record your quarterly calculations and confirmation numbers.

NOTE: Wherever the word "wages" is used: tips, sick pay (except long term sick pay as defined by IRS regulations), deferred compensation and other taxable income must be included. However, most section 125 cafeteria plan deductions (except 401k) are exempt from JEDD taxes.
