¹ Estimated Taxable Income - To avoid interest and penalty charges your estimate must equal either 100% of your prior year JEDD tax liability or 90% of your current year tax liability. This estimate must also be paid in four equal quarterly payments.

² Due Date - Fiscal filers must file and pay their quarterly estimated payments by the end of the 4th, 7th, 10th and 13th months following the start of their fiscal year.
