SWPPP Check List

SILT FENCE

- Silt fence is required to surround the project area to keep sediment from leaving the project site into the Right-of-Way, adjoin properties, streams, rivers, ponds, lakes, or sewer
- Silt Fence must remain in place until 75% of final site stabilization vegetation has grown back

SLOPE PROTECTION

- Slope protection is required with mat/ blankets or quick growing vegetation and slope matting
- Slope protection must remain in place until 75% of final site stabilization vegetation has grown back

SITE SPOILS

- All site spoils (e.g. excavated or excess grading material) must be seeded with fast growing vegetation using erosion mats/ blankets.
- Spoils piles must be surrounded by silt fence until removed from the project site
- Vegetation and erosion mats/ blankets must stay in place until spoils are removed from site or used for finish grade

INLET PROTECTION

- Inlets must be protected accordingly to the type of inlet
- Inlet protection must remain in place until 75% of final site stabilization vegetation has grown back

WASH OUT LOCATION

- All wash out must be contained on site and not leave the project site into the Right-of-Way, adjoining properties, streams, rivers, ponds, lakes, or sewers.
- There should be a designated location on site for concrete trucks and other related equipment to wash out or clean in to
- This area is to remain in place until all concrete work or final grading is complete

City of Akron SWPPP Specs

- 1. THE CONTRACTOR SHALL CONTROL WASTES, GARBAGE, DEBRIS, WASTEWATER, AND OTHER SUBSTANCES ON THE SITE IN SUCH A WAY THAT THEY SHALL NOT BE TRANSPORTED FROM THE SITE BY THE ACTION OF WINDS, STORM WATER RUNOFF, OR OTHER FORCES. PROPER DISPOSAL OR MANAGEMENT OF ALL WASTES AND UNUSED BUILDING MATERIALS, APPROPRIATE TO THE NATURE OF THE WASTE OR MATERIAL, IS REQUIRED. COMPLIANCE IS REQUIRED WITH ALL STATE OR LOCAL REGULATIONS REGARDING WASTE DISPOSAL, SANITARY SEWER, OR SEPTIC SYSTEMS.
- 2. PUBLIC OR PRIVATE ROADWAYS SHALL BE KEPT CLEARED OF ACCUMULATED SEDIMENT. OFF-SITE VEHICLE TRACKING SEDIMENT SHALL BE MINIMIZED. CONSTRUCTION VEHICLES ARE LIMITED TO THE CONSTRUCTION ACCESS ROAD NOTED ON PLANS. BULK CLEARING OF ACCUMULATED SEDIMENT SHALL NOT INCLUDE FLUSHING THE AREA WITH WATER. CLEARED SEDIMENT SHALL BE RETURNED TO SITE.
- 3. A) EXCEPT AS PREVENTED BY INCLEMENT WEATHER CONDITIONS, ALL DISTURBED AREAS OVER 50 FEET AWAY FROM THE STREAM BED TO REMAIN INACTIVE FOR MORE THAN 14 DAYS SHALL BE STABILIZED BY SEEDING AND MULCHING, COVERING, OR BY OTHER EQUIVALENT EROSION CONTROL MEASURES. PERMANENT SOIL STABILIZATION SHALL BE PROVIDED WITHIN 7 DAYS AFTER FINAL GRADE IS ESTABLISHED.

B) EXCEPT AS PREVENTED BY INCLEMENT WEATHER CONDITIONS, ALL DISTURBED AREAS WITHIN 50 FEET OF THE STREAM BED TO REMAIN INACTIVE FOR MORE THAN 14 DAYS SHALL BE STABILIZED BY SEEDING AND MULCHING, COVERING, OR BY OTHER EQUIVALENT EROSION CONTROL MEASURES. PERMANENT SOIL STABILIZATION SHALL BE PROVIDED WITHIN 7 DAYS AFTER FINAL GRADE IS ESTABLISHED.

- 4. DISTURBED AREAS WHICH WILL REMAIN IDLE DURING THE WINTER MONTHS SHALL BE STABILIZED USING SEEDING AND MULCHING. SUCH STABILIZATION MEASURES MUST BE INSTALLED NO LATER THAN NOVEMBER 1.
- 5. THE EROSION CONTROL PLAN SHALL BE IMPLEMENTED ON ALL DISTURBED AREAS WITHIN THE CONSTRUCTION SITE. OTHER EROSION AND SEDIMENT CONTROL ITEMS MAY BE NECESSARY DUE TO ENVIRONMENTAL CONDITIONS
- 6. DURING THE PERIOD OF CONSTRUCTION ACTIVITY, ALL EROSION CONTROL MEASURES SHALL BE MAINTAINED BY THE CONTRACTOR. AT THE COMPLETION OF CONSTRUCTION, THE CONTRACTOR SHALL COORDINATE THE TRANSFER OF MAINTENANCE RESPONSIBILITIES, IF

REQUIRED, WITH THE OWNER. MAINTENANCE SHALL BE IN ACCORDANCE WITH THE "OHIO RAINWATER AND LAND DEVELOPMENT HANDBOOK (2006)".

- 7. POST CONSTRUCTION STORM WATER MANAGEMENT: ALL DISTURBED AREAS SHALL HAVE ADEQUATE VEGETATION TO FILTER POLLUTANTS AS MUCH AS PRACTICAL. LOCAL LAWS REGARDING THE DISCHARGING OF OIL AND OTHER POLLUTANTS INTO DRAINAGE-WAYS SHALL APPLY.
- 8. ALL EROSION AND SEDIMENT CONTROLS SHALL BE INSPECTED IN ACCORDANCE WITH THE CONDITIONS OF APPLICABLE NPDES PERMITS.
- 9. ALL TEMPORARY EROSION AND SEDIMENT CONTROL PRACTICES SHALL BE REMOVED AND DISPOSED OF AFTER FINAL SITE STABILIZATION HAS ACHIEVED 75% VEGITATION GROWTH. TRAPPED SEDIMENT SHALL BE PERMANENTLY STABILIZED TO PREVENT FURTHER EROSION.
- 10. THE EROSION CONTROL PLAN MUST BE RETAINED ON-SITE AT ALL TIMES DURING THE PERIOD OF CONSTRUCTION.
- 11. EROSION CONTROL DEVICES REMOVED DURING GRADING OPERATIONS SHALL BE REINSTALLED AT THE END OF THE DAY OR DURING INCLEMENT WEATHER.
- 12. EROSION CONTROL BLANKETS WITH MATTING WILL BE USED ON DITCHES GREATER THAN 1.5% AND ALL OTHER SLOPES GREATER THAN 6% GRADE.
- 13. OFF-SITE VEHICLES TRACKING SEDIMENT SHALL BE MINIMIZED.
- 14. ALL CONSTRUCTION AND DEMOLITION DEBRIS SHALL BE DISPOSED OF IN AN OHIO EPA APPROVED C&DD LANDFILL, AS REQUIRED BY OHIO REVISED CODE (ORC) 3714.
- 15. NO TURBID STORM WATER MAY BE DISCHARGED OFF SITE.
